THE SOS ILLINOIS MODEL OF CARE IS AN INNOVATIVE APPROACH TO TRADITIONAL FOSTER CARE BY OFFERING CHILDREN THE OPPORTUNITY TO LIVE IN A SAFE, NURTURING, SINGLE-FAMILY HOME WITH THEIR BROTHERS AND SISTERS IN THE CARE OF A FULL-TIME, PROFESSIONALLY TRAINED FOSTER PARENT IN A VILLAGE SETTING. CHILDREN BENEFIT FROM THE STABILITY OF REMAINING WITH THEIR SIBLINGS AS WELL AS THE SUPPORT OF NEIGHBORING SOS ILLINOIS FOSTER PARENTS AND THE ENTIRE COMMUNITY.
